APPENDIX A

Michael Tayler District Council - October 2019

One of the potentially significant areas that I have been involved with over the last few weeks is the air quality committee which is part of the environmental health department of the council. Clearly this has important ramifications following the declaration of the environmental and climate emergency and hopefully should influence areas such as planning and health and well-being. I have been particularly keen to find out potential health impacts of short term high concentration of pollutants, up until now, as with most councils measurements are usually made using diffusion tubes on lampposts etc, which measure NO2 and particulates over long periods (ie days or weeks) rather than hours. The council is now buying some more expensive equipment which will measure more pollutants over shorter periods of time, one of which provisionally will go in at the bottom of Town Street in Thaxted because of interest, not only in traffic pollution, but also because it is on the flight path for Stansted. Little Easton was also brought up by both Louise Pepper and myself for more work with diffusion tubes.

Work on the District(and also Essex County) Council Health an Well-being committee has also been useful. Much less successful has been engaging with highways. I will work with Martin and other councillors to find a better process.
