### APPENDIX A

### **Local Plan Examination**

Following the submission of the draft Uttlesford Local Plan to the Secretary of State last week, the Council received a letter from the Planning Inspectorate giving details of the inspectors appointed to examine the soundness of the Local Plan; they are Louise Crosby and Elaine Worthington.

Having two inspectors appointed to examine a local plan is not unheard of; the Local Plans for Cambridge and South Cambridgeshire, for example, had two inspectors appointed to examine their plans. In their case, one of the inspectors was the lead inspector for the examination, although both inspectors sat for some sessions and one or other of the inspectors sat for other sessions. We will, in due course, find out more as to what the arrangements will be for our own examination.

### **Duty to cooperate meeting**

Officers met with representatives from the Greater Cambridge Planning Service (the newly merged planning service for Cambridge City Council and South Cambridgeshire District Council) on Friday 18 January. Essex County Council and Highways England were also in attendance.

Officers continued to press for the scope of the cumulative assessment of transport impacts for the Wellcome planning application to take account of North Uttlesford Garden Community. There was agreement to collaborate on strategic transport investment in the wider area, and to develop a Statement of Common Ground to inform the Uttlesford Local Plan examination.

A member level meeting is being arranged to continue the discussion.

## **Updated Heritage Impact Assessment**

During both the Regulation 18 consultation and the Regulation 19 representation period, Historic England made representations on the Uttlesford Local Plan. These representations raised a number of concerns relating to the plan, particularly North Uttlesford Garden Community.

Following the Reg 18 consultation Donald Insall Associates was commissioned to undertake a Heritage Impact Assessment (HIA) to address these concerns. A draft of the HIA was published in May 2018 to inform the Reg 19 draft plan and a number of recommendations from the HIA were incorporated into the draft plan (policies SP6, SP7 and SP8).

After the Reg 19 representation period, Donald Insall continued to work on the HIA. In undertaking further work, the Council has sought to better explore the heritage constraints on the site and identify, as far as possible, appropriate mitigation measures. This work involved meetings with Historic England to discuss the work and site visits to North Uttlesford and Easton Park.

The updated HIA has now been finalised and will be uploaded to the website shortly. We will also be forwarding the document to PINS and will continue discussions with Historic England seeking to complete a Statement of Common Ground to set out the areas of agreement and disagreement to assist the appointed inspectors.

### **Thaxted Neighbourhood Plan Referendum**

Residents in Thaxted voted on whether to agree the new Thaxted Neighbourhood Plan. The referendum results were 861 votes in favour of making the Neighbourhood Plan and 35 against (and one rejected vote). The turn-out was 35%.

Following this result, reports will be taken to Cabinet on 12 February and then Full Council on 21 February, recommending the Council 'make' the Neighbourhood Plan; it will then become part of the development plan for the purposes of considering planning applications in the parish.
